#### Delegate's Report: Elaine M.

Elaine reported - Delegate News March 2025 New from WSO. WSO has seen a 30% drop in registered group numbers since the pandemic. The impact is that newcomers may have difficulty finding us. If you know of a group using the Al-Anon name that is not registered, please remind them of the importance of using the AlAnon/Alateen name. Group Records starting in March, forms will be available online to simplify the group registration process. No paper forms, Faster updates, more accurate records, easier reporting. Road Trip Designation Confirmed An opportunity to meet the Board which is going to be held in Omaha Nebraska October 25, 2025 Board Meeting Highlights A call for Regional Trustees is out -- please refer to ctalanon.org for eligibility criteria. – Suggestion- tap someone on the shoulder rather than just make a statement. Regional Trustees Application "The AA International Convention" to be held July 3-6 in Vancouver Canada- who's planning to attend? Al-Anon is looking for volunteers to help, consider signing up to help at the event. Beyond the Group Level Service Definition, the Board recognized it was inconsistently using "service beyond the group level" on its applications. To clarify this, Trustees discussed the phrase at the January 2025 meeting as it is undefined in the 2022-2025 Al-Anon/Alateen Service Manual. The discussion revealed diverse perspectives and aimed to specify requirements for World Service positions. Consequently, the Board decided to have the Nominating Committee define specific service requirements for each role, replacing the vague term. Past A.A. Membership Requirement for WSO Service Following the October 2024 Policy Committee's confirmation of the existing "Service Participation by Al-Anon Members Who Are Also Members of Alcoholics Anonymous (A.A.)" policy, the Board of Trustees was requested to re-evaluate the current criteria for members applying to serve as WSO Volunteers and At-Large Committee members. The Policy Committee recommended that the Board reconsider using "cannot have ever been" rather than "are not" members of A.A. as stipulated in the policy. This is Elaine's last year as Delegate and the Area Officers of Panel 63 will be ending their term on

December 31, 2025. It's a good time to start thinking about who will stand next for these roles for the out going term of 2025? As you are aware, we will be conducting a vote in June regarding the conclusion of the six year trial period as outlined in "Gratitude in Working Clothes." I would like to inquire if you have discussed the eligibility criteria with your GRs. Additionally, do you believe it would be beneficial to hold a Town Hall meeting to address this matter? Elaine is preparing for Conference and NERD which will be held from March 14-16 to discuss topics and prepare new Delegates for the Conference. It will be held in Rocky Hill where our Past Delegates, Gail, Gina and Marcia will be hosting the event. I'm preparing for the Conference with lots of reading material. It will be held from April 23- 28, followed by a visit to Steppingstones on April 29th, 2025. CAI Delegates were requested to submit a Conference Agenda Item Chosen Agenda Items - AlAnon Family Groups (CAI) for consideration at the Conference. Connecticut submitted one agenda item; more information will be provided soon. Previous CAI topics can be found online. Visit CAI to view past topics. We are still in need for a Public Outreach Coordinator for Connecticut to keep up our active committee's enthusiasm. Convention is just a few weeks away, have you registered? # Alt Delegate's Report: Katie D.(Read by Karen V.)

I enjoyed seeing many of you at the Serenity Breakfast and found it to be a wonderful time of fellowship, learning and good food. Otherwise, it has been a quiet month for the most part, however, at Elaine's suggestion, I am starting a project to create a transition guide/manual for the District Representatives, and would like to hold a focus group to get input from DR's and Alt. DR's to understand what information you would find valuable when transitioning into these important service positions, and what items you may have that would be good to share across the Districts. I will send an email to schedule the focus group when I return but please send me an email with any thoughts you have in the meantime. Also, for the Spring Assembly in June, we will have a "job fair" as our workshop during the Assembly, and I will be asking all the Area Coordinators to attend to share information about their service positions, as well as some DR's and officers. ## **District 3 Report Morgan R.**

We had a GR workshop in October focusing on best practices with our in-person, hybrid, and PEG meetings. This was well-attended both online and face-to-face, thanks especially to Katie D. who made the trek from Granby! Our district made a group conscience about its financials in January, including establishing a prudent reserve, revisiting our contribution amounts, and allocating funds to public outreach, literature, and Alateen. In this process, we discovered that our district has been making quarterly contributions of \$312 (\$1248 per year) to the CT Area since the '90s. We also increased mileage reimbursement from \$.30/mile to \$.50/mile to reflect current rate. We had several opportunities to grow, especially when it came to the ways we spend our collective basket dollars moving forward, hearing the minority opinion, and making decisions based on facts rather than fears. We made some investments in technology (Chromebook, wireless mouse and keyboard, speaker, extension cord) to help our hybrid district meetings run more smoothly. We find that this format is the most accessible to the members in our district; attendance is really good! District 3's Public Outreach committee has sent speakers to East Haven High School, Hamden Middle School, and Wilbur Cross High School. Speakers were very well received and invited to return later in Spring. We have a district "anniversary" event planned for May 21. Food, fellowship, and a screening of the Lois documentary are on the agenda! More information to follow as we get closer. We are proud to say that Connecticut's most populous Alateen meeting is back in business thanks to Dung L. and Still Don R. !!!!!! Yay, team! Lastly, we are looking forward to co-hosting the Spring Assembly with District 4 in June!!

## District 4 Report Jen B.

District 4 includes the towns of: Ansonia, Derby, Seymour, Milford, Shelton, Monroe, Trumbull, Stratford, and Bridgeport. We have a total of 17 Al Anon meetings in our district:10 - In person,3 - Zoom Only,4 – Hybrid. There are two Alateen meetings in our district.1- Trumbull,1- Seymour High School (for students only) There are 2 additional Zoom meetings in Milford that are no longer part of the district. Instead, they have elected to be part of the worldwide electronic meetings. Our District 4 Group Records position has been filled. Our District 4 Literature Coordinator position has been filled. There continues to be a major push in our district for each group to have a PO coordinator to encourage spreading the message.

These warranties can be applied to all our relationships if we want to live in harmony and peace with others and with ourselves Concept 12 is filled with wisdom to help me in my day to day living • In Warranty One I am reminded to have some savings and not go to extremes, which I did in the past. I just need to have enough. I can be reasonable when it comes to what I want and what I need and make appropriate choices. • Warranty Two, reminds me I have to face the problems that may arise with me in regard to authority. I came to understand that I have no authority on anybody else, but myself. • Warranty Three helps to consider everyone's' views during discussions that affect myself and others. It is important when making decisions that everyone involved voice their opinion regarding decisions to be made • Warranty Four talks about controversy and Warranty Five talks about democracy in thought and action. This tells me that I should avoid controversy, so I can remain democratic. These Warranties suggest that I am careful of how I act, react and interact. Because of the need to cancel the Breakfast due to snow, the chatter that was heard was that people without tickets were told to just go and they would be able to gain admission. Kate, the Convention Chair sent out an email blast the day before advising people not to do that. They would not be admitted to the event. We had 233 registered and 193 attended. We were consistent in that we held to the cutoff date per the hotel contract. If you did not purchase your ticket by the cutoff date, there was no admission to the event. The total for printing was \$19.14 Questionnaires were in black and white to cut expenses Recommendations We need to change the arrival time to 8:30 AM. Coffee was delayed because the hotel had another breakfast event at the same time because we utilized our snow date. A written protocol is now in place for cancellation. That should not be an issue in the future if we remain with our original date. 1 person needs to manage both mail in and Event Brite registrations. Bring Convention flyers. It was an honor to Chair this event. It was made possible by all of you that created a wonderful morning. It had been many years that I had been unable to attend because of living outside of the US that I missed this event. I was so grateful to be back in the fellowship of Al-Anon here in CT where my life turned full circle. I regret that my personal family situation does not allow me to stand for Convention Chair 2026.

**Stephen M. Alt. DR2** – Would like to see more fun at the area meetings.

Morgan R. DR3 - really appreciated and was very grateful that the members have taken the time to have an area inventory. The set up is good. She stated she found the reports confusing. The delivery can be different. Elaine M. Delegate- her suggestion to the members to attend area meetings regularly. Have a service sponsor. This is how she learned about the fellowship. Being present and reading the service manual. Desperate enough to learn.

**Janine G. DR 11** – Communicate well at the area level would like more time at the area meeting to better understand the reports. District meetings are too long trying to passing the reports on to the GRS.

**Lisa G. Area Chair** – Working on extending time as a group to communicate better.

**Stephanie R.** In some of the group meeting that she attended there was no business portion. GR's distribute Area reports. This is part of links of service and it is a critical part. Desperate to be willing member and then to be enthusiastic.

**Carol D. BOD Chair** loved the reminder of enthusiasm. Bring service manual to group business meetings. Reiterated the importance of links of service.

**Lisa G. Area Chair** – shared what other states do regarding their assembly. Some states have more than 2 assemblies a year other have weekend long assemblies. Area meetings in other states can be a minimum of 3 hours.

**Marissa W. DR 6 -** Suggested to leverage out the willingness and thoughtfulness of our members to attract members in service as one example of an issue that may be of concern to the Area. Additional Conversations are needed.

**Elaine M. Delegate** – Spoke about the history of the area meetings. In the past a survey was done and the DR"S of that time wanted to reduce the area meetings.

**Deborah C. DR1** Spoke about the need for the reports at the area meeting. She shared how she summarized the reports so that GR's can feel more confident in sharing the information to members. She found that the GR"s did not read the summary. How does a DR address this issue enthusiastically.

**Morgan R. DR 3** spoke about more enthusiasm. Take 5 minutes of every meeting to share a little information from the area. Instead of sharing all at once.

**Janine G.** She would like to see something like the AFG Connect for the DR's in our Area.

**Jennifer DR12** Spoke about the desperate willing member. She has a service sponsor and a sponsor. She has stepped up in her program. She "will be" enthusiastic she came in desperate - a willing member to get her personal recovery. This program is saving her life.

**Tech Coordinator Resume- Elaine M. Mark H** submitted his resume for this position. He shared his experience strength and hope to the members and his desire to fill this position. He was honest and would not be able to step in until June 2025. He has been a member for 5 years and has a sponsor. He was the Al-Anon Convention – Electronic Chair and Co-Chair.
