- Celebrating Worldwide Unity-Registration for the International Al-Anon Convention in Vancouver British Columbia on July 5-7, 2013 is open on the Web site: www.al-anoninternationalconvention.org, or call (757-563-1600). Registration for the Al-Anon's 2013 International Convention Fees are: \$115 U.S. (must be received by 12/31/12), \$140 U.S. (between 1/1/13 and 05/31/13) and \$ 165 U.S. (June 1st through the Convention) Come a day early and attend a separate, "day of connecting" event on Thursday, July 4th. Preregister for this separate event for a fee of \$15 U.S. by May 31, 2013.
- The 2013 World Service Conference theme is: Our legacies: The Spiritual Journey of Changing "Me to "We". To be held on April 14-18th, 2013, at the Wyndham Virginia Beach Oceanfront Hotel in Virginia Beach, Virginia.

- "A Task Force is a temporary unit of people established to work on a single defined task or activity." Service Manual p.g. 64. The Task Force Committee Report titled "Guidelines for Interpreters for Al-Anon / Alateen Events in Connecticut will present their recommendations to the Assembly. We have met regularly since January 2012 and look forward to presenting our recommendations.
- A Task Force is currently working on revisions on the Connecticut Alateen Guidelines. More information to follow.
- Each Area has further developed its own Area Alateen Safety & Behavioral Requirements. Every Al-Anon member involved with Alateen Service has met these requirements and has agreed to follow them. All Alateen Annual Recertification paperwork needs to be filled by our Area Alateen Process Person (AAPP). In order not to jeopardize our Alateens and be in full compliance with the World Service Office, complete the recertification process in a timely manner. Please contact Harry N., (AAPP) and or your District Representative for any questions regarding this annual process.
- We have found much success with the use of the Knowledge, Based, Decision, Making method. Forward your ideas through your District Representatives for future Thought /Task Forces for our Area. I will review and appoint the Chairperson; provide the five questions of KBDM. Currently a motion has been approved by AWSC for a Task Force including groups & districts to gather more information on the use of sign language.
- Provide agenda items to the Area Chairperson through your District Representative you want to be discussed at the Area World Service Committee; two weeks prior to the Area meeting. "Participation is the key to harmony."

In conclusion, I'm truly grateful to serve as your Area Delegate and appreciate your willingness to share my reports and broaden our knowledge of worldwide Al-Anon.
