Delegate's Report

Hello Friends,

Welcome to Fall. Hope you all had a great summer.

The 70th Anniversary Celebration held on July 10, 2021 was quite the celebration and was well attended by over 1000 participants. For those not able to attend the 70th Anniversary Celebration, WSO will be replaying the talks on the *Al-Anon Family Groups* Mobile App on September 21st at 8 am, October 9th at 2 pm, and November 17th at 8 pm. All times are Eastern Time. The replay will appear as a meeting option on those days.

The July 2021 Chairman of the Board of Trustee was released in August and here are some of the highlights:

- The 2022 World Service Conference (WSC) will be held in Tarrytown, NY, April 26 through April 30, 2022. The theme for 2022 WSC will be "Enhancing Our Recovery through Abundance, Unity, and Understanding".
- The Board approved the Revised 2021 Budget which has a \$233,753 deficit. Per WSO Treasurer, the \$233,753 deficit represents one month of contributions or 2 weeks of expenses. Although year-to-date literature sales are above the YTD budget by \$86,831, literature sales have still not returned to pre-pandemic numbers. Year-to-date contributions are below budgeted expectations by \$111,557. We continue to need members' contributions in order to meet the Revised Budget!

 The mail-in and the online registration deadline is Friday, October 8, 2021.
- Policy Committee reports on it progress with topics that are generated by the fellowship regarding issues and concerns that need clarification or interpretation in light of the Twelve Traditions and Twelve Concepts of Service as well as Progress of

- work being completed by Policy Committee work groups, task forces, and thought forces.
- The Strategic Leadership Team (SLT) facilitated a 2022 Strategy Options session which provided information to help Board members prioritize and select the Strategies which will most effectively advance the Goals and Envisioned Future of the AFG, Inc. Strategic Plan. The SLT will now take the selected Strategies and identify the resources needed to support them. SLT will make another presentation to the Board at the October 2021 Board meeting where Strategies will be given final approval. At-Large Committee members may serve up to six one-year terms, beginning in January.
