Opportunities to Serve on the Executive Committee for Real Property Management (ECRPM). I have attached the information outlining the qualifications and details about serving AFG as an ECRM. After reviewing if you feel you have met the criteria, The deadline for submission is August 15, 2024.

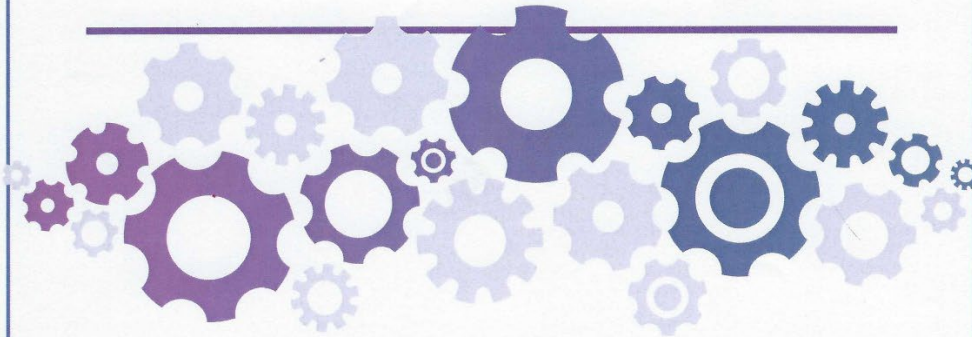
